Since August 1, 2011, Outpatient <u>Substance Abuse</u> service codes have their own service class "OPR". The service codes listed below comprise the OPR service class.



Type of Service--Select "Substance Abuse"


Type of Care--No action required, keep at default "Select"

- Service Class--select "Substance Abuse Outpatient Services OPR"
- Number of Visits/Units cannot exceed 72

# Reminder to Use the Updated Form and Fax for Psychological Testing Requests

The Psychological Evaluation Request (PER) form for pre-authorization of neuropsychological or psychological testing has been updated and is available online. This form can be found at <a href="https://www.vbh-pa.com">www.vbh-pa.com</a>. Once you have entered the VBH-PA website, click on the following tabs:

- 2.) On the left-hand side of the page click on Provider Forms
- 3.) Under Clinical/Utilization Management Forms, find **PER Form tab** and click

Testing requests submitted on the old form are no longer being accepted (effective September 1, 2011) and will be returned to you. The updated form must be used to request authorization.



## **Heroes of Recovery**

An advocate for user-designed mental health programs whose personal

experiences and frustrations with the mental health care system helped propel the field's "consumer" movement, Joseph Rogers has provided impassioned, visionary leadership in transforming mental health care in this country.

Diagnosed with paranoid schizophrenia at age 19 and told that he was incapable of holding a job, Mr. Rogers descended into a life of homelessness and desolation until he eventually found treatment and a place to stay at a YMCA in New Jersey. After fate led him to a job as an outreach worker at a mental health center, he moved to



Philadelphia where he began work in 1984 at the Mental Health Association of Southeastern Pennsylvania (MHASP), then a small non-profit agency with a dozen staff members. Over the last 20 years, he has transformed MHASP into a \$14-million organization with 300 staff, the majority of whom are consumers. He is now president and CEO.

Mr. Rogers soon began exhorting a new philosophy for mental health care, one based on the principle that individuals who have shared similar experiences can help themselves and each other. In 1984, under MHASP's auspices, he founded the Self-Help and Advocacy Resource Exchange (Project SHARE), which has become the umbrella organization for programs that provide such essential services as peer support, drop-in centers, housing, homeless outreach, mentoring, and job training. Today, MHASP operates 40 such programs. In 1986, with federal funding, Mr. Rogers founded the National Mental Health Consumers' Self-Help Clearinghouse. The clearinghouse provides thousands of U.S. mental health consumers and consumer-run organizations with the tools to be successful advocates and to establish and operate peer-run services. He has helped coin the term "consumer" and has become active in working to reform the methods used by police in apprehending "Emotionally Disturbed Persons" (EDPs).

Kimberly Kerr has been with Value Behavioral Health of PA (VBH-PA) since July 2008. She is the Provider Field Coordinator for the SW6 counties' children and adolescent providers. Kimberly is a licensed Professional Counselor with a Master's degree from Duquesne University in Community Counseling. Prior coming to VBH-PA she was the director of five behavioral health services with Wesley Spectrum Services for Westmoreland and Somerset counties.



Kimberly is married and lives with her husband and a rescued pooch named Barney in the Laurel Highlands. Her favorite pastimes are gardening and laughing with friends and family. When Kimberly was born she was the first baby of the New Year in Los Angeles, California.

### **Functional Behavioral Assessment (FBA) Trainer Workshop**

# Wednesday, October 26, 2011 9:00 am - 4:30 pm *Child Welfare Training Center, Mechanicsburg, PA*

**ABOUT THE TRAINING:** The intention of this free one-day training is to increase the pool of professionals who can facilitate the two-day FBA training using the BAS FBA DVD/Curriculum, and to assist trained staff in trouble-shooting problems in support planning and conducting FBAs. Participants of this session will also be able to train additional qualified staff within their agencies as FBA trainers. Manual and DVDs will be provided.

WHO SHOULD ATTEND: This workshop is intended for current FBA trainers and other individuals who have an interest in training others in FBA. This includes Adult Autism Waiver Behavioral Specialist (BSS) providers, as well as BSCs, Program Managers or Managed Care Trainers within the BHMCOs and the BHRS provider community. Trainers should feel comfortable in mentoring others in the use of FBAs and the development of support plans for persons with ASD.

### PRE-REQUISITES:

- 1. Hold a Master's Level degree
- 2. Have 1,000 hours of experience conducting FBAs
- 3. Meet one of the three additional requirements below:
  - A. Be a current trainer using the BAS FBA DVD/Curriculum; OR
  - B. Have participated in the two-day FBA Workshop provided by either BAS, a regional ASERT,
  - or an approved trainer using the BAS DVD/Curriculum, and have passed the required test; **OR**
  - C. Be a BCBA (Board Certified Behavior Analyst).

### **CONTINUING EDUCATION**

This training is approved for continuing education for Board Certified Behavior Analysts, PA Educators, Social Workers, National Board Certified Counselors, and Psychologists. General Training hours will also be provided.
